# **Distracted Driving Legislation Fails**

One of those bills in each the House and the Senate was the handheld device law. Currently, it is illegal to "manually enter multiple letters or text into" your phone "as a means of communicating with another person" or "read any email or text message transmitted to" your phone. If you are reading carefully, however, it is technically legal to scroll Facebook, Twitter or Instagram while you are driving as long as you are not manually entering multiple letters or text

This proposed law in the Senate (S.B. No. 1341) proposed to changed the law from these two circumstances to make it unlawful for "any person to operate a motor vehicle on the highways of the Commonwealth while using any handheld personal communications device unless the device is specifically designed and configured to allow hands-free and voice operation and is being used in that manner." Operating a motor vehicle has been interpreted as extremely broad and includes everything putting the key in the ignition to activate the electronics, or cruising at 60 mph down the highway.

The House bill (H.B. No. 1811) was a little different in that it changed the law to make it unlawful for "any person while driving a motor vehicle on the highways in the Commonwealth to hold, in his hand, a handheld personal communications device while physically manipulating the device to view, read, or enter data." In my opinion, the House bill hits the nail right on the head. This is the problem that we see with people driving 60 mph on the Lynchburg Expressway.

Numerous substitutes and amendments were offered and went back and forth between the House and the Senate. At the end of the day, the two chambers could not reach an agreement on the proper language of the new proposed law.

At least 16 other states and the District of Columbia have banned the use of a handheld device by all drivers. Virginia has not vet done so. Historically, Virginia is what you would call a late adopter. It usually takes much longer for Virginia to change things like this than many other states. For controversial bills, it usually takes a couple vears for the bill to "grow" on our legislators and for some compromise to be reached. The old joke is how many lawyers does it take to change a light bulb in Virginia? Five. One to change the light bulb and four to talk about how great the old light bulb was.

The problem in this case is that the relatively new light bulb wasn't that great to begin with, but somehow it passed the General Assembly a couple of years ago. Law enforcement officials are saying that the current law is difficult to enforce because it narrowly applies to certain tasks on a cell phone but not to others. However, if the law banned any physical manipulation of a cell phone, enforcement would go up. And presumably, injuries and deaths from distracted driving would go down.

The National Highway Transportation Safety Administration has said that "[d] uring daylight hours, approximately 481,000 drivers are using cell phones while driving ...Texting is the most alarming distraction. Sending or reading a text takes your eyes off the road for 5 seconds. At 55 mph, that's like driving the length of an entire football field with your eves closed...Distracted driving killed 3,477 people on America's roads in 2015." It is estimated an additional 391,000 people have been injured in motor vehicle crashes involving distracted driving in 2015.

I think it is high time that Virginia join the ranks of states that prohibit the use of a cell phone while driving. I'm sure we've all seen too many drivers traveling at 65 plus miles per hour on route 460 with his eyes on a cell phone. This distraction is too dangerous for our citizens and ought to be illegal.

Even though the legislation failed, we can all do our own part voluntarily. We can put the phone down while we are driving and we can tell others to do the same. What are your thoughts on this issue? I'd love to hear from you!
